With reference to your application on the subject noted above, I am directed to grant recognition to your school from classes I st to VIII (without aid) w.e.f. 1938-89 session, subject to the fulfilment of the following terms and conditions:-

- That the school shall abide by the provisions of Delhi School Education Act and Rules, 1973 framed thereunder as well as the instructions issued from time to time.
- 2. That the school shall admit students without any discri--mination of caste and creed and preference shall be given to the students of Saraswati Vihar.
- That the school shall appoint more full time qualified and eligible staff for all the classes of the school as per the present norms of the department.
 - 4. That the school shall equip the science Lab. as per the norms of the department and suitable facilities for practical work shall be provided to the students.
 - 5. That a proper library shall be established and facilities for reading room shall also be made available for students as well as teachers. More approved standard books shall be purchased. Books as per the ratio of 10 books per student may be added and facilities for reading room may also be provided immediately.
 - o. That the adequate sports materials shall be purchased for out door games and in-door games during the year 1988-19.
 - 7. That the school shall strictly abide by the provisions of Delhi school Education Act and Rules, 1973 and payment shall be made as per the section 10(1) of Delhi School Education Act, 1973 to all the employees through crossed cheque.
 - B, That the enrolment in each section shall not exceed the humber of students calculated @ 12 sq.ft. per student for

- 10. That the school shall not run any pre-primary and unrecognised classes or any other activities within the school premises and all the recognised classes shall be run at one place. . - 12. That all the facilities prescribed under Rules 50 and 51 of the BSER, 1973 shall be made available to the students. Provision of Rules 6, 7 and 9 be structly observed.
- 13. That the service contract between the management and the employees shall be executed immediately.
- 14. That the arrangement of good drinking water shall be made available to all the students as well as to the teachers and sanitary facilities shall also be provided to the students adequately.
- 15. That the violation of any instructions/orders/conditions/ rules and regulations of the department shall lead to the withdrawal of recognition of the school and class IX shall not be opened without the prior approval of the Director of Education, Delhi.
- 16. That the management of theschool shall create a Reserve Fund of R. 5000/- (Rupees five thousand) only in a joint name of the Director of Education and the Manager of the school in any scheduled bank within a month.
- 17. That the school society shall apply for the allotment of land and will construct the building as per the specifications of Dte. of Edn., Delhi within a period of three years.
- 18. That the management of the school shall provide all the facilities as per rule 50 and all conditions as required under rule 51 shall be complied with.
